Other Site Characteristics

Colline marnoso-arenacee che, oltre agli habitat segnalati con codice comprendono estesi boschi di: Quercus cerris, dell'alleanza Lathiro montani-Quercion cerridis; Quercus cerris ed Ostrya carpinifolia dell'associazione Aceri obtusati-Quercetum cerris; Ostrya carpinifolia riferiti allo Scutellario-Ostryetum. Le cenosi forestali sono intercalate da: pascoli appartenenti al Centaureo bracteayae-Brometum erecti; prati-pascoli dell'Achilleo collinae-Cynosuretum ed arbusteti del Pruno-Rubion fruticosi.

4.2 Quality and importance

L'area collinare rappresenta uno dei migliori esempi del manto vegetale delle colline marnoso-arenacee dell'Umbria nord-occidentale. Vi è, infatti, un mosaico di vegetazione composto da boschi di varia natura (talvolta governati a fustaia), arbusteti, pascoli e piccole zone coltivate. Il sito presenta quindi una elevata biodiversità unita ad un discreto stato di conservazione generale che lo rendono di notevole interesse a livello appenninico. Tra la fauna da segnalare anche Buteo buteo, Falco tinnunculus (specie poco comuni).
