Other Site Characteristics

Tratto del Fiume Tevere caratterizzato dalla presenza degli habitat segnalati con codice ed attribuiti alle alleanze Potamogetonion pectinati (3260) e Salicion albae (92A0), nonché dallo sviluppo, in alcune anse, di formazioni ad Alnus glutinosa, riferibili all'alleanza Alno-Ulmion (91E0), talvolta interrotta da vegetazione di tipo pioniera con piante annuali o da cenosi igro-nitrofile (6430).

4.2 Quality and importance

Settore tra i meno antropizzati del Fiume Tevere e di una certa importanza per la presenza di lembi di ontaneta ad Alnus glutinosa, ultimi esempi per la Valle del Tevere e, più in generale, per le valli fluviali dell'Italia centrale. Tra le specie floristiche è segnalata Iris pseudacorus, rara a livello regionale. Tra la fauna è stato segnalato anche Buteo buteo, Cettia cetti e Falco tinnunculus (poco comuni).
