Other Site Characteristics

Valle largamente incisa tra rilievi calcarei appenninici, in cui gli habitat segnalati con codice sono costituiti da: stazioni di Buxus sempervirens (5110), ampiamente diffuso all'interno dei boschi; arbusteti a Juniperus communis, attribuiti all'ordine Prunetalia spinosae (5310); pascoli aridi dell'Asperulo purpureae-Brometum erecti (6210), boschi di Fagus sylvatica con Ilex aquifolium (9210). I versanti della valle, inoltre, sono ricoperti da boschi di Ostrya carpinifolia, dell'associazione Scutellario-Ostryetum.

4.2 Quality and importance

Esempio di vallone calcareo con vegetazione tipica, ben conservata, costituita da boschi di Ostrya carpinifolia, alle quote più basse, e di Fagus sylvatica con Ilex aquifolium nei settori più elevati. Il sito acquista grande valore geobotanico per la presenza della più importante (per consistenza della popolazione) stazione di Buxus sempervirens dell'Italia centrale. Tra la fauna è stato segnalato anche Accipiter nisus (specie rara), Buteo buteo (poco comune).
