Other Site Characteristics

Piccolissima area submontana, racchiusa all'interno di profondi valloni con suolo acidificato, che si contraddistingue per la presenza di interessanti nuclei boschivi a castagno (*Castanea sativa*), talvolta con alberi secolari. Le aree circostanti sono rivestite da boschi di carpino nero (*Ostrya carpinifolia*), dell'associazione Scutellario-Ostryetum carpinifoliae e da cespuglieti a ginepro comune (*Juniperus communis*).

4.2 Quality and importance

Questi castagneti costituiscono uno degli ultimi nuclei a *Castanea sativa* presenti nel settore centrale dell'Appennino umbro e quindi assumono un particolare valore ed interesse fitogeografico e storico, oltre che paesaggistico ed economico (nel passato queste formazioni avevano un importantissimo ruolo nella vita delle popolazioni montane). La presenza di alcuni alberi secolari, nonché di specie erbacee ed arbustive di sottobosco, ne aumenta, inoltre, il valore naturalistico.
