Other Site Characteristics

Rilievi calcarei di modesta elevazione posti all'estremo confine meridionale della regione. Gli habitat segnalati con codice sono costituiti da: aggruppamenti a Junipers oxycedrus (5211); pascoli terofitici dell'ordine Thero-Brachypodietalia (6220); formazioni a Quercus ilex attribuite alle associazioni Viburno-Quercetum ilicis, Orno-Quercetum ilicis e Cephalanthero-Quercetum ilicis (9340); pinete a Pinus halepensis riferite alla subassociazione Orno-Quercetum ilicis pinetosum halepensis (9540). Inoltre, nei versanti più freschi, si rinvencono boschi a dominanza di Ostrya carpinifolia inquadrati nell'associazione Scutellario-Ostryetum.

4.2 Quality and importance

Sito di grande interesse geobotanico poichè nei settori meno elevati presenta specie ed associazioni vegetali di tipo mediterraneo, mentre in quelli più alti, per la presenza di boschi misti a sclerofille sempreverdi con caducifoglie, sono rappresentate le leccete tipiche delle aree appenniche. I versanti a nord, poi, ricoperti da boschi con Ostrya carpinifolia mostrano un campione della vegetazione di caducifoglie tipica delle aree collinari appenniniche. Tra le entità floristiche presenti, oltre alle endemiche, è stata indicata Elaeoselinum asclepium, poichè rara a livello regionale. Tra la fauna è stato indicato anche Buteo buteo e Falco tinnunculus (specie poco comuni).
