Other Site Characteristics

Complesso di colline argillose, parzialmente ricoperte da sedimenti villafranchiani, dove si sviluppano lembi boschivi a Quercus cerris e Quercus frainetto, inquadrabili nell'alleanza del Teucro siculi-Quercion cerridis. Questi boschi rappresentano una delle rare stazioni ombre di Quercus frainetto.

4.2 Quality and importance

Questi boschi a Quercus frainetto sono situati al limite nord-orientale del loro areale italiano e quindi assumono un grande valore fitogeografico a livello nazionale. Sono, inoltre, ben conservati (governati a fustaia) e pertanto hanno anche una buona importanza naturalistica. Tra le entità floristiche presenti è stata indicata Malus florentina, rara a livello regionale (Quercus frainetto è presente in Umbria in sole altre 4 stazioni). Tra la fauna è stato indicato anche Buteo buteo (specie poco comune).
