4.2 Quality and importance

Area rupestre e semirupestre di notevole importanza fitogeografica per la bellezza paesaggistica e per la presenza di una stazione di Ephedra major, relitto conservativo del terziario e specie molto rara in tutta la penisola italiana. Tra la fauna è stato segnalato anche Potamon fluviatile fluviatile (specie in continua rarefazione), Buteo buteo (poco comune).
