Other Site Characteristics

Rilievi prevalentemente calcarei dove gli habitat segnalati con codice si riferiscono ad arbusteti a *Juniperus communis* (5130) attribuiti all'ordine *Prunetalia spinosae*; aggruppamenti a *Festuca spadicea* (6170); pascoli a *Bromus erectus* inquadrabili nell'alleanza *Phleio ambiguibromion erecti* (6210); nardeti a *Nardus stricta* (6230). Nell'area considerata sono inoltre presenti pascoli a *Sesleria nitida*, boschi a *Fagus sylvatica*, dell'associazione *Polysticho-Fagetum*, e ad *Ostrya carpinifolia*, dell'alleanza *Laburno-Ostryon*.

4.2 Quality and importance

Esempio di area alto-montana appenninica con faggete (a nuclei governati a fustaia) e pascoli a *Bromus erectus*, ben conservati e molto ricchi di specie. Particolare interesse rivestono i pascoli a *Festuca spadicea*, non conosciuti per nessun'altra località umbro-marchigiana. Tra le entità floristiche del sito, oltre alle endemiche, è stata indicata *Gentiana lutea*, rara a livello appenninico. Tra la fauna è stato segnalato *Buteo buteo* (specie poco comune), *Martes martes* (specie molto rara).
