Other Site Characteristics

Rilievo collinare di natura calcarea dove, accanto ai castagneti (9260) ricchi di esemplari secolari, si rinvencono boschi di Ostrya carpinifolia attribuiti allo Scutellario-Ostryetum e, negli impluvi più freschi, una vegetazione inquadrata nel Carpino betuli-Coryletum avellanae.

4.2 Quality and importance

Il principale valore del sito risiede nella presenza di boschi di Castanea sativa, governati ad alto fusto, con numerosi esemplari secolari ed ultrasecolari, che costituiscono ambienti divenuti rari nell'Italia peninsulare per motivi socio-economici (spopolamento delle aree montane) e per la diffusione di malattie parassitarie. Tra la fauna è stato segnalato anche Accipiter nisus (specie rara).
