Other Site Characteristics

L'area comprende il tratto sorgivo che da Bagnara si estende fino a Nocera Umbra. La vegetazione idrofittica è caratterizzata prevalentemente da Ranunculus trichophyllus e Fontinalis antipiretica, mentre quella elofittica e fanerofittica da Phragmites australis, Sparganium erectum, Typoides arundinacea e diverse specie di Salix.

4.2 Quality and importance

Il tratto di fiume compreso nel sito si distingue, dal punto di vista geobotanico, soprattutto per la presenza di vegetazione idrofittica e per il basso inquinamento delle acque. Tra le specie più significative è stato segnalato Salix cinerea considerata rara a livello regionale. Tra la fauna da segnalare anche Cettia cetti (poco comune).
